A. Juvenile Hall

i. The number in this month's snapshot is higher, as it includes out of County youth awaiting transfer. The school at Juvenile Hall youth is still waiting for their tablets. MCOE is working on the internet security. The Hall will begin construction this summer for security enhancements.

B. Youth Court

- i. This Sunday, film and panel discussion, "Finding Justice," Marin City
- ii. There is interest in starting a Youth Court in Petaluma
- iii. 4 tribes from Mendocino are visiting to observe Youth Court
- iv. San Rafael City Schools submitted a grant to use Restorative Justice to divert youth from the juvenile justice system.

D. Legislation update
