II. JJDPC - involvement, opportunities and activities

A. CA state JJC workshop

i. Juvenile Justice Commissions from throughout the state gathered in Sebastapool to share activities and best practices. Most noted the need for improved collaboration. Linda Evans spoke about the importance of advocacy and the "Ban the Box" campaign/legislation

B. Youth Officers Roundtable

i. The Commission decided that it was important to continue with the Youth Officer Roundtables. Beverly agreed to take the lead on planning. Potential area of focus: diversion, including a panel. Date: April.

C. Meeting with the Police Chiefs re: youth citation data

 Dana reviewed the information she plans to share at the Chiefs' meeting on January 11th. The focus of the discussion will be: data collection and diversion.

A. Juvenile Hall and Juvenile Probation

- i. In reviewing the Juvenile Hall snapshot, the Commission had a discussion about how to reduce the number of V.O.P. violations. Strategies included: ensuring that families are in the loop, creating an understanding about what's going on with the judges and families and providing incentives for doing well. Beverly agreed to look into V.O.P. research, to better understand best practices of juvenile probation programs with low V.O.P.s.
- ii. The Commission talked about the "Wall of Change," an inspirational piece of art (photos), which honors adults who have successfully completed adult probation.

B Youth Court

 Don reported that Youth Court is going well. The Tamalpais District has agreed to refer cases, pro bono. Don is doing a Harm Reduction curriculum for Tam High. And, he will be talking with Siskiyou County about bringing Youth Court there, to create a community-based probation program.
