- I. Call to Order and introductions
Commissioners present: Dana Pepp, Melissa Valencia, Kathy Williams, Don Carney, Beverly Farr
Guests: Jacklyn Hutton

Minutes of April 2-18. Melissa moved to approve April 2018 minutes. Kathy, seconded MSC. Passed unanimously.
- II. JJDPCC - involvement, opportunities and activities
 - A. Youth Officers Roundtable
 - i. The YOR sub-committee presented the last draft of program content, noting confirmed speakers and activities for the session. Date is May 22, 10-12:00 pm. Committee will meet again to finalize plans.
 - B. "Know Your Rights" Workshop
 - i. Melissa reported on workshop. There were approximately 15-17 students. Lucia from Canal Alliance did an excellent job of presenting information—Melissa mentioned that everyone in the room learned. They also had good handouts, including red cards with rights information which they also handed out the next day and left in different places. For next time, will put out information sooner, think of other ways to advertise. Participants said it was informative and wished it was longer. Attendants were about 95% female.

 - A. Dana brought KIND bars as well as cards and assignments for Commissioners and friends of the Commission to deliver to assigned police departments. to Members or friends of the Commission will provide Kind bars to police departments (along with dog biscuits for those with canine departments.)
 - B. Youth holding institutions that will require inspections by Commission - - SRPD, Central Marin, Sheriff Marin City. Team assignments made.
 - C. Juvenile Hall
 - i. Juvenile Hall now up to 16 boys, one girl—higher than in a long time. Many of those now in are there for violation of probation.
