Meeting Minutes

- I. Call to Order and introductions
Commissioners present: Dana Pepp, Melissa Valencia, Kathy Williams, Beverly Farr, Don Carney

Guests: Jacklyn Hutton, Robyn Roberts, Eric Olson, Nicole Lescano

Minutes of May. Kathy moved to approve May 2018 minutes. Melissa seconded. Passed unanimously.

- II. JJDPC - involvement, opportunities and activities
 - A. Youth Officers Roundtable
 - Reviewed evaluation results from YOR, and members shared their own perceptions. Generally received very positively. Article was published in Marin IJ. Discussion about next steps. General agreement that we explore the idea of doing some sort of follow-up to the marijuana workshop and also begin preparation for a YOR on equity and racial disparities in the criminal justice system. Discussion about integrating the first topic with a SLEP meeting. Also discussed working with the Blue Ribbon Coalitions for drug prevention. Beverly will contact coordinator for Marin Prevention Network. Dana will talk with Ken Lippi.

- III. Updates, reports, follow-ups
 - A. Inspections: Melissa and Robyn have scheduled inspection at Central Marin. Kathy and Don completed inspection at Marin City Substation last week. Jacklyn and Beverly will schedule visit to San Rafael Police Department in next couple weeks.
 - B. Reports on delivery of KIND bars. At least one department (Novato) sent a thank-you card. All others were delivered.
 - C. Juvenile Hall
 - i. Juvenile Hall now up to 21, 12 boys, 9 girls—higher than it's been in a long time. Many of those now in are there for violation of probation. End of school year seems to be a factor.
 - D. Youth Court
 - i. Hawaii is coming to visit, to consider a youth court in Kauai (Kamehameha).
 - ii. Siskiyou County still pursuing their interest in Youth Court.
 - iii. Santa Clara also wants to replicate a program.

- iv. Don will be in Sacramento, making presentations in September and October.
- v. Addend: Don reported after the meeting that he had received a 15k grant to develop a Youth Court in La Cañada Flintridge and a suspension diversion in the Glendale School District.
