- I. Call to Order and introductions
Commissioners present: Dana Pepp, Beverly Farr, Don Carney, Lori Frugoli, Melissa Valencia

Minutes of June. Don moved to approve June 2018 minutes. Jacklyn seconded. Passed unanimously.

- II. Updates, reports, follow-ups
 - A. Youth Officers Roundtable

Upcoming plans – Beverly reported on conference call with Linda Henn and Bridget Clark of the Coalition Connection to discuss follow-up to YOR on cannabis. Suggested that a task force of moderate size be set up to develop strategies for follow-up actions to take collaboratively. These could include a consistent, equitable continuum of services and consequences. Commission approved follow-up, and Beverly will arrange another meeting.

YOR – Dana suggested doing a fall YOR on mental health. There was interest from Lori, Jacklyn, Kipp and Dana.
 - B. Reports on deliveries of KIND bars. Some received thank-you notes.
 - C. Inspections: All inspections have been completed. Melissa and Robyn reported on inspection of Central Marin. Kathy and Don completed inspection at Marin City Substation. Jacklyn and Beverly did the inspection at San Rafael Police Department.
 - D. The Commission needs to inspect Juvenile Hall. We will connect with Eric about a date in October. Those interested included: Robyn, Beverly, Ashley, Anna, Jaleh and Kathy.
 - E. Juvenile Justice Commissions were encouraged to support petitions to object to separating and confining children. The Marin JJDPC could request to do an inspection if they were going to be in our county—but they are not.
 - F. Youth Court
 - i. \$15,000 grant to do Pasadena
 - ii. \$20,000 grant from Davidson Middle School to train in restorative practices for suspension diversion
 - iii. Ross Valley engaging in big effort to do restorative practices

- G. Discussion about whether to send JH Snapshot to local Grand Jury (Grand Jury has recommended closing JH because not cost effective.) Dana will contact Mike Daly about doing an Op Ed piece or something about the issue.
 - H. New Commissioners' Status
 - i. Jacklyn and Robyn are still waiting to hear regarding their live scans.
 - I. Recruitment: Would like to have 11-12 commissioners, to be able to be more productive and focus on County prevention efforts.
