I. **Guest Speaker:** Marin DUI Court Presentation

What is Marin County doing with “under 21” DUI drivers? Youth get a deal and participate in the CHP “Smart Start” program.

REAL DUI Court: A real trial takes place in front of a high school (Marin Oaks) on 3/29. Youth will form an advisory council (jury) and the judge will decide. Their goal is to create an educational forum for youth.

A. Youth Officers Roundtable

1. Marijuana working group update

Don was not present for an update. The group is working on creating the action plan. The SLEP marijuana panel has been rescheduled for next week. They will talk about the spectrum of consequences. The group’s goal is to bring recommendations re: consistency, consequences and increasing the perception of harm.

Saturday, “Teen Cannabis and Alcohol Use, by Community Psychotherapy Institute” took place at MCOE. Over 50 families attended.

2. Mental Health 101

Ashley and Jacklyn are recruiting for the youth panel. The invitation was sent and a reminder will go out this week. There was immediate interest. Dana will send out a reminder to the YOR and Commission.
