II. Speaker 10,000 Degrees – Welcome Alex! 5:00 – 5:30

Alex Stern spoke about his work at 10,000 Degrees and background on what they do. 10,000 Degrees is a nonprofit from California which supports students succeed to and through college. They support more than 2,200 students attending college nationwide. All the programs and ran by fellows who have recently graduated college and many are alumni of 10,000 Degrees. Their students graduated with about 85% less in debt than the students who didn't use 10,000 Degrees. He spoke about their new partnership with Novato Unified. He spoke about their METAS programs, which is for English language learners, to support them and help them reach their goals.
