- I. Call to Order and introductions

Minutes of September. Dana moved to approve September 2018 minutes. Passed unanimously, with minor change.

- II. Updates, reports, follow-ups

A. Youth Officers Roundtable

Marijuana follow-up: Beverly reported what came out of the SLEP poll regarding topics and sequence for SLEP meetings. Excerpt from report:

Based on the responses we've received the overall interest of the group demonstrated the following priority and sequence:

1. **Suicide prevention / depression / anxiety and mental health**
2. **Marijuana use and other substance abuse (with significant interest in vaping / Juules**
3. School Security and Emergency Preparedness
4. Partnership between Hospitals / Law Enforcement on 5150 (related to #1
5. Digital World (sexual harassment, pornography, social media, cyber bullying, digital foot prints)
6. Mandated reporting related to teacher / coach predators

With the understanding that all of these topics are important and often closely related, given the wisdom and input of the group, we are scheduling presentations for our top two priority topics at our next two SLEP meeting as follows:

- **October 17, 2018 -- Suicide prevention / depression / anxiety and mental health (including discussion on 5150 and local hospitals)**
- **January 16, 2019 – Marijuana and other Substance abuse (including a focus on Vaping)**

Beverly will contact Don and the members of the Coalition Connection to convene steering committee to discuss follow-up. Dana will call Ken Lippi to discuss what SLEP is going to do with the two topics. That will inform what we do with YOR.

- B. The Commission needs to inspect Juvenile Hall in October. Reviewed revised versions of staff/student protocols. Dana will make edits and send out to the members who are on inspection team.
- C. Research from Annie E. Casey Foundation: Dana suggested that someone do research on interesting articles on Foundation web site on topics such as ethnic disparities and equity. Robyn volunteered to do some research.
- D. Judge Wood reported on work with Probation Department to develop proposal to have more of a presence in middle schools.
- E. Eric Olson has taken Kevin Lynch's position as Director of Juvenile Services. The new director at Juvenile Hall will be announced soon.
